- B. Store materials in accordance with manufacturer's recommendations.
- C. Handle using methods that will prevent damage to finished surfaces.

2.3 MATERIALS

- A. Accessories General: Shop assembled, free of dents and scratches and packaged complete with anchors and fittings, steel anchor plates, adapters, and anchor components for installation.
 - 1. Grind welded joints smooth.
 - 2. Fabricate unites made of metal sheet of seamless sheets with flat surfaces.
- B. Mirror Glass: Annealed float glass, ASTM C1036 Type I, Class 1, Quality Q2, with silvering, protective and physical characteristics complying with ASTM C15103.
- C. Keys: Key all locking accessories alike; provide 2 keys per lock.
- D. Stainless Steel Sheet: Satin Finish (UNO) ASTM A666, Type 304.
- E. Stainless Steel Tubing: ASTM A269/A269M, Grade TP304 or TP316.
- F. Galvanized Sheet Steel: Hot-dipped galvanized steel sheet, ASTM A653/A653M, with G90/Z275 coating.
- G. Fasteners, Screws, and Bolts: Hot dip galvanized; tamperproof; security type.
- H. Steel: Satin finish, unless otherwise noted.

PART 3 EXECUTION

3.1 EXAMINATION

- A. Verify existing conditions before starting work.
- B. Verify exact location of accessories for installation.
- C. Verify that field measurements are as indicated on drawings.

3.2 INSTALLATION

- A. Install accessories in accordance with manufacturers' instructions in locations indicated on drawings. Remove and discard any protective covering.
- B. Install plumb and level, securely and rigidly anchored to substrate.
- C. Mounting Heights: As required by accessibility regulations, unless otherwise indicated.

3.3 PROTECTION

A. Protect installed accessories from damage due to subsequent construction operations.
